RESOLUTION 2024.09.12

AUTHORIZATION FOR THE BOARD OF MAYOR AND ALDERMEN OF JASPER TO ALLOW AND REGULATE PUBLIC COMMENTS AND REQUESTS TO BE PLACED ON THE AGENDA IN COMPLIANCE WITH TENN. CODE ANN. §8-44-112

NOW, THEREFORE BE IT RESOLVED by the Legislative Body of the Town of Jasper meeting in regular session that the Board of Mayor and Aldermen be authorized to allow and regulate public comments and requests to be placed on the agenda in compliance with Tenn. Code Ann. §8-44-112 by implementing the following procedures for persons desiring to speak and address the Board of Mayor and Aldermen at Town meetings.

Public Comment Period

There shall be a public comment period for each meeting with actionable items on the agenda, except for employee disciplinary proceedings. Comments shall be limited to topics listed on the agenda. The total public comment period shall be for no more than a total of Fifteen (15) Minutes. If an individual wishes to address the Board, he/she shall sign up on the form provided before the beginning of the Town meeting to request time to speak. Each speaker shall be given no more than Three (3) Minutes per speaker of time to speak. Delegations shall select only one (1) individual to speak on their behalf unless otherwise determined by the Board of Mayor and Aldermen.

Adding an Item to the Agenda

Individuals desiring to appear before the Board of Mayor and Aldermen as an agenda item shall submit a written request with descriptive materials to the office of the Mayor at minimum Two (2) Weeks before the meeting. If the request is approved by the Board of Mayor and Aldermen, the item will be placed on the agenda. Individuals placed on the agenda will be recognized at the beginning of the meeting and given Five (5) Minutes of time to speak when their item is addressed on the agenda. All requests submitted will be included in the Board of Mayor and Aldermen packets.

BE IT FURTHER RESOLVED by the Legislative Body of the Town of Jasper meeting in regular session that any person/(s) who by their conduct either verbally or physically disrupts the Town meeting may be subject to criminal charges as set forth in Tenn. Code Ann. §39-17-306:

39-17-306. Disrupting Meeting or Procession.

- (a) A person commits an offense if, with the intent to prevent or disrupt a lawful meeting, procession, or gathering, the person substantially obstructs or interferes with the meeting, procession, or gathering by physical action or verbal utterance.
- (b) A violation of this section is a Class A misdemeanor.

We, the undersigned Town Aldermen members, move the adoption of the above Resolution.


